### Mayor's Report:

Mayor Millman read a letter from Spence Engineering in regard to the Hudson Valley Regional Council awarding the Village the "Resilience Award" for the Village's continued participation in the Municipal Separate Stormwater Sewer System (MS\$) Program as part of the Stormwater Consortium of Rockland County.

Mayor Millman stated that Homeland Towers will conduct a second balloon test on Sunday, November 17 between the hours of 9 a.m. and 12 p.m. at 350 Haverstraw Road. This is in connection with its proposal to locate a cell tower behind the facility, between it and the parkland.

Mayor Millman offered his congratulations to Senator Bill Weber and Congressman Michael Lawler on their election wins. Recently Congressman Lawler was able to get funding for the Town and Villages for pedestrian infrastructure. Our portion will enable us to fix infrastructure around Village Hall. Our neighbor, Suffern, received substantial money to fix Memorial Drive, which has been closed for several years. This will hopefully reduce the traffic on Orchard Street and Lake Road within the Village once Memorial Drive is reopened.

## **Building Department Report:**

The following is the Building Department Report for the month of October 2024:

- (10) building permits were filed. A total of \$22,356 in permit fees were collected.
- (6) Certificates of Occupancy were issued.
- (9) locations were inspected; \$450.00 in Fire Inspection fees were collected during the month.
- (4) code violations were issued. (1) violation was cleared up.

## Historic Preservation and Parks Commission (HPPC) Report

The commission met on Wednesday, October 15<sup>th</sup>.

## Member Status

• Due to the Local Law Amendment the member status of 6 regular commissioners and one ad-hoc must change to 5 regular members plus 2 ad-hocs. The members were instructed to consider changing their status (one member would have to change to an ad-hoc). If no one volunteers to change their status, the Village Attorney stated this would be done by the Mayor and Board of Trustees.

## Jazz Festival Update

  - o Applicant David Fried, 63 Viola Road, presented a plot plan with proposed single-family dwelling with the removal of the current home and landscaping plan. He will be present at the November meeting with more renderings.

## Time Capsule

• The commission spoke about digging up the current time capsule on a significant date like May 7, 2025, or July 4, 2026. They discussed the possibility of using the old capsule instead of buying a new one and have a plaque made to put over the burial site.

With no one from the HPPC wishing to speak, Mayor Millman closed this portion of the meeting.

#### **Public Comment:**

Mr. Baruch Poliatzky of 51 Mayer Drive thanked the Mayor and Board for their good work. He had several questions regarding the cell tower. His first question was the location of the cell tower. Mayor Millman explained the location was behind the parking lot at 350 Haverstraw Road on the hill. He also wanted to know who was paying for the tower. Mayor Millman explained that tower is being built by Homeland Towers and they will lease the property where the tower is being built and they will be paying revenue rental to the Village so there is no cost to the taxpayers. Mr. Poliatzsky asked if the Village knew what frequency range the tower will be operating. Mayor Millman stated he did not know the answer to that but added that there will be a Public Hearing with Homeland Towers where those questions could be asked. A date has not been set yet, but the information will be published on the Village website and in the local newspaper. Mr. Poliatzky asked if the Board had looked into the safety aspect of the tower. Mayor Millman assured him the safety of the Village residents is his first priority and that comprehensive data on safety was being supplied to the Village and looked into by the Board. Mr. Poliatzky had some additional data that he had collected on safety and asked that the Board look at it. The information was given to the Deputy Clerk to disperse to the Board for review. Village Attorney Berbit, who is also a former electrical engineer and understands the subject, who has been working with Homeland Towers spoke on the safety of the tower as he knows it. He indicated a frequency range he believes of 800 to 2400 HMZ. Also, he mentioned that exposure reduces by distance per the inverse square rule, thus using a cell phone represents greater exposure.

PLEASE TAKE NOTICE, that a Public Hearing will be held by the Board of Trustees of the Village of Montebello on Thursday, November 7, 2024 at 7:00 p.m. or as soon thereafter as the matter can be heard at the Dr. Jeffrey Oppenheim Community Center, 350 Haverstraw Road, Montebello, N.Y. 10901, to consider a local law which would allow the Village of Montebello to adopt a budget for the calendar year commencing January 1, 2025 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

All members of the public and all interested parties are invited to attend and participate. The proposed Local Law will be available for inspection and review at the Village Office during normal working hours, Monday through Friday, 9:00 a.m. to 4:00 p.m."; and

WHEREAS, the following documents were received and included in the record:

WHEREAS, the Public Hearing portion was opened at 7:31 p.m. with a motion by Deputy Mayor Caridi, seconded by Bruce Egenhauser, all in favor, and closed at 7:33 p.m. with a motion by Deputy Mayor Caridi, seconded by Bruce Egenhauser, all in favor, with no one else from the public other than Mr. Poliatzky, who asked a question which was answered by the Mayor and Village Attorney, wishing to speak and the Village Board duly deliberated in public.
