Mayor's Report:

Mayor Millman thanked the Town of Ramapo Highway Department for the great job they did clearing the roads and our Village Hall and Dr. Jeffrey Oppenheim Community Center parking lots during the last snowstorm. There were no complaints. If there are any complaints, issues, or suggestions from the residents, they should reach out to Village Hall.

Mayor Millman reported helping to set up and attend a meeting with our Village Attorney, Ed Day, our County Executive, the Town of Ramapo, Villages of Airmont and Suffern along with the DOT, regarding area traffic. We are trying to come up with a viable global solution not only now but into the future.

Mayor Millman stated we are moving forward on renting the top floor of the Community Center offices. The space has been updated with new carpeting and paint and we are looking forward to a new tenant for this rental.

Mayor Millman announced that the next edition of our Newsletter will be the beginning of March, so check your mailboxes and our website.

Mayor Millman stated that the Village will once again be holding the Montebello Jazz Festival on the grounds of Village Hall. This was started several years ago by Gary Goldberg at the Mansion. Mayor Millman has spoken to a music professional to assist booking groups. This event will take place in September, date and time to be determined. In addition to the bands, we anticipate having food trucks. The announcement to the public will be made once the details have been finalized.

Mayor Millman announced the use of the new sound system for use during meetings in order for the public to hear better.

Mayor Millman stated that he has received questions about cameras being installed in various areas of the Village. He reminded everyone that these are being installed per an agreement with the Town of Ramapo and the Town of Ramapo Police to be used in emergency situations and that they are license plate reader cameras.

Marsel Amona, owner Jonathan Lockman, Village Planner

Jonathan Lockman, Village Planner, prepared a packet of files for the Board to review. He carefully highlighted points of the packet – including what has been submitted by Mr. Amona to date. All as more particularly referenced in the following resolution including an explaining the history of various approval and newer proposals regarding the subject 17 acres; the proposed revised subdivision into 6 lots including 9 duplexes and a possible pool complex on one lot in condominium ownership; the SEQRA EAF forms, map and details for circulation; declaration of lead agency; etc.

Title: Conducting Public Hearing on Local Law 1 of 2024 to Amend the Zoning Code §195-62 Rural Preservation Overlay District, and associated definitions and listings in the Table of General Use Requirements, to allow the conversion of the approved Stonehedge subdivision, approved with 11 new single-family homes, alternately to construct 3 new single-family homes and 16 new duplex residences (in 8 buildings)

WHEREAS, the Stonehedge Subdivision was approved by the Planning Board on March 12, 2019, with 12 lots, one containing the preserved historic Minetto farmstead and 11 lots for new single-family residences; and

WHEREAS, a plan of the aforesaid Stonehedge Subdivision with 12 lots, dated April 16, 2019, was submitted to the Village Planning Board Clerk, and the approved plans were never signed by the Planning Board Chairman or filed with the County of Rockland; and

WHEREAS, the owner of the Stonehedge Subdivision petitioned the Village Board on or about June 21, 2023, requesting that the Village of Montebello Zoning Code be amended to allow the redesign of the approved Stonehedge subdivision, which was approved with 11 new single-family homes, alternately to construct 3 new single-family homes and 16 new duplex residences, while still preserving the Minetto farmstead; and

WHEREAS, the Village Board, wishing to provide an opportunity for this alternative housing type, referred the matter to the CDRC for its review and recommendations, and requested that the Village Planner and Village Attorney work with the applicant and the applicant's consultant team to prepare a local law to accomplish the goal of allowing the substitution of duplex houses in the Rural Preservation Overlay, while creating a sensitive design within the objectives of the overlay, maintaining the Spook Rock Road historic and scenic road corridor. and preserving the Minetto farmstead; and

WHEREAS, a draft of Local Law 1 of 2024 has been submitted, with a footer dated February 21, 2024, which has been reviewed by the Village Attorney and Village Planner;

WHEREAS, a proposed planimetric plan for Stonehedge Heights Subdivision has been submitted, stamped by Steven Sparaco, PE, Sparaco & Youngblood, PLLC, with the latest revision date of February 9, 2024;

WHEREAS, the following supporting documents have been submitted in support of the SEQRA review:

- Traffic Evaluation, Stonehedge Heights, by Colliers Engineering & Design, signed by Philip Grealy PhD, PE, and Ronald Rieman, dated August 16, 2021, and revised November 24, 2023.
- Willingness to Serve Letters from Utilities:

- b) That the Village Board accepts the Part I Full Environmental Assessment Form ("FEAF") signed by John Lange for the Stonehedge Heights Corporation on January 19, 2024, as adequate for distribution and finds that it appropriately describes the proposed action; and
- c.) That the Village Board accepts the Part II Environmental Assessment Form ("EAF") as prepared by Jonathan Lockman, AICP on behalf of the Village Board as Lead Agency, dated February 21, 2024, and finds that it appropriately describes the potentially significant impacts of proposed action which the sponsor, Stonehedge Heights Corporation shall address in a future Part III submission; and

2. That a Public Hearing shall be held on March 20, 2024, beginning at 7 pm local time, on said Local Law amending the Zoning Code as aforementioned, and per the referenced attachments; and

WHEREAS, in his memo dated February 8, 2024, referenced as of set forth hereinafter, the Village Engineer after checking with prospective landscaper references and reviewing their proposals, recommends the award of the Landscaping Agreement to Evergreen Landscaping, Inc. as the lowest proposed package cost.
