STONEHEDGE

Public Hearing reopened at 7:26 pm with a motion by Deputy Mayor Caridi and seconded by Trustee Golden, all in favor.

Public Comment in Public Hearing:

1. Mr. Eli Wells – 196 Spook Rock Road stated that the traffic is very bad now and that if you add 50 more cars it will be atrocious. He stated that if you allow this project to proceed, what stops every home from becoming a two-family home. He also stated that the water tables are rising with all the construction in the area.

Mayor Millman stated that he had a meeting with the Town of Ramapo, and they will be diverting some roads off of Spook Rock and including right and left turn lanes onto North Airmont Road.

2. Mr. Gunanand Persaud, Jr. -202 Spook Rock Road wished to know why is the Village permitting multifamily homes in this area. He stated that traffic on Spook Rock Road is very bad and that there are many large trucks, and their speed is an issue or limit the amount of traffic on Spook Rock Road.

Mayor Millman stated that this would be the only location within the Village that this type of development will be allowed. Mayor Millman stated that he will be calling a meeting with the Town of Ramapo Police to discuss the speed.

- 3. Mr. Helmut Schmidt -217 Spook Rock Road stated he has lived here since before the village and that there was too much traffic, and the vehicles go way too fast for the walkers and bikers.
- 4. Mrs. S. Persaud—202 Spook Rock Road wished to discuss the speed of the vehicles and large trucks on Spook Rock Road. She stated that she was nearly rearended while turning into her driveway and had contacted the police. She suggested that a digital speed sign be installed.
- 5. Mr. Gunanand Persaud—183 Spook Rock Road stated that he was not permitted a multifamily home and it should not be permitted.
- 6. Ms. Rochelle Weinberg 6 Topaz Court discussed the congestion on Spook Rock Road. She stated that everyone enjoys their large properties and the rural character of the Village. She does not wish to see lights or sidewalks installed and no duplexes.
- 7. Mr. Jacob Schlesinger 4 Topaz Court objects to the zone change. He stated that if he applied to make his home into a two family that he would surely be denied. He stated that he chose Montebello to have the proper zoning laws that do not permit this type of zoning.

Mayor Millman stated that this zoning is only in this area and not permitted anywhere else.

- 8. Mrs. C. Schlesinger -4 Topaz Court objected to a law change for a developer. She stated that she moved here for their own privacy and the lack of congestion and to keep things the way things look. She stated that any subdivision must have tree buffers and no swimming pools as they will be too loud.
- 9. Mr. Joel Weinberg 6 Topaz Court stated, why we should allow this? He stated that this project was already asked to be downgraded to allow 11 homes and now he is asking it to be downgraded to allow 19 homes. There will be too much noise. Too much density. He is against the two pools proposed. He stated this proposed development will devalue his home and his property. He stated that the Mayor and the Board should be listening to the residents that have lived here for 30 years first before a developer that does not live here. He stated that the property should be preserved. He stated that the zoning for this project should take into consideration the homes that are near it. He stated you should take the value of their homes into consideration. He stated that the amount of noise from all these proposed homes will be loud.

Discussion ensued regarding the number of homes proposed and the amount of land involved. The Mayor stated that he and the Board are very dedicated to the Village and its development and needs.

10. Ms. Weinberg – 6 Topaz Court stated that as a prior realtor she agrees that property values will decline. She is against a developer proposing this project just to make a quick buck. She

stated that two pools planned are in total disregard for her privacy. That with at least two cars per house that will bring a lot of vehicles to Spook Rock.

Mayor Millman stated that many smaller homes have many cars in their driveways and that there is nothing we can do about that.

- 11. Mr. Victor Henriquez -219 Spook Rock Road stated that he and his family escaped living in a city environment and do not want it back.
- 12. Mr. Jeffrey Sapir 10 Topaz Court reiterated opposition to this proposed plan.
- 13. Mrs. S. Persaud -202 Spook Rock Road asked why they need two pools when the Spook Rock Pool will be nearby.

Mayor Millman explained that anyone can apply for a pool.

- 14. Mr. Gunanand Persaud, Jr. 202 Spook Rock Road totally opposes this project.
- 15. Ms. Sapir -10 Topaz Court stated that this proposed project will change the entire character of the village. She stated that the contractor had an agreement for 11 homes, but that was not enough for him. The contractor wants to change the character of our area. She stated that she opposes the project.
- 16. Ms. Weinberg 6 Topaz Court asked if condominium associations are permitted.

A discussion ensued with Mayor Millman and Village Planner Lockman describing what a condominium allows.

17. Ms. Weinberg – 6 Topaz Court wanted to know what the next procedures would be.

Mr. Marsel Amona addressed the Board. He thanked everyone for taking the time to discuss this. He is open to move the pool complex away from Topaz, perhaps even changing to a clubhouse. He also would consider, if feasible, shifting the single-family homes to up around the cul-de-sac near Topaz, and moving those duplexes. He was asked to amend other changes.

The Public Comment will be held in abeyance until the next Board of Trustees meeting on May 15, 2024 at 7:00 pm and continuation of the Public Hearing after an in depth discussion ensued with the Mayor, Trustees, Village Planner, and Contractor.

In addition to the Police Department, the enforcing officials are amended to include the Building Inspector, Assistant Building Inspector, and Code Enforcement Officer who all may issue appearance tickets for offenses.
